CEO MESSAGE

2024-25 NSW Budget Updates

The housing announcements in NSW's 2024-25 budget mark a crucial stride in tackling our housing crisis, with over 9.000 households currently waiting for priority social housing.

Our challenge is substantial!

As mentioned in a range of recent budget announcements, long-term plans and investments, coupled with collaboration between the government and the community housing sector, are essential to enhance the delivery of social and affordable housing. This allows community housing providers to construct more homes, offering relief to NSW's most vulnerable families.

The highlight of this budget is the \$6.6b investment in housing and homelessness services over the next four years – the single biggest investment by a NSW state government since the end of WWII. Further, a commitment from Homes NSW to work with the state peaks on co-designing ways and means to spend that money to achieve the top-level targets set most effectively. Additionally,

- \$202.6m over four years to the Aboriginal Housing Office to support critical capital maintenance on First Nations social homes, in addition to the repair of 3,500 AHO homes.
- support for ACCOs to meet funding and wage gaps so they can continue to deliver critical services and grow the provision of culturally safe responses to Aboriginal people experiencing homelessness.
- \$5.1b over four years for new social housing, including constructing 8,400 new homes, of which 2,200 will be replacement dwellings.
- the first tranche of recurring, dedicated funding for critical maintenance and minor works (\$810m), including to support the upgrade of 30,000 homes.
- \$527.6m over four years to reform temporary accommodation, build back specialist homelessness services, and establish the Homelessness Innovation Fund (HIF) to leverage the skills and capacity of the housing and homelessness sector.

Over the next several weeks, I will provide further insights into how the budget affects the Aboriginal housing sector and Aboriginal Community Housing Providers (ACHPs) more specifically. The ACHIA NSW team will also continue to use the fortnightly CEO forums to ensure we hear directly from you about how to resolve housing

and homelessness challenges with localised, community-driven solutions so we can continue to elevate your voices and advocate to the government.

Vital Statistics Project

ACHIA NSW has been engaged by the National Aboriginal and Torres Strait Islander Housing Association (NATISHA) to undertake a two-staged project to identify and analyse the potential for land activation within the Aboriginal Community Controlled Organisation (ACCO) sector - The Vital Statistics from the National Indigenous Estate – NSW project.

The project will empower and elevate ACCOs and ACHPs in NSW by providing power through data. Further, it will shape, strengthen and deliver an accurate picture of the potential contribution of the NSW Aboriginal community housing sector to the development of new housing stock and how this is represented to government and financing bodies.

The Project

The project will be delivered in two key stages.

Stage 1

To identify and analyse significant and diverse ACCO land holdings in NSW and their 'vital statistics'.

Stage 2

To develop a framework for activating a proportion of the land parcels identified in Stage 1.

- Help accessing more than 70 government rebates and vouchers through the Savings Finder program.

An onboard **Business Concierge** will also be available from 18 June to 22 August to provide businesses with free, one-on-one guidance to navigate government, apply for licences, and access other business services.
