## **ACHIA NSW Hits the Road**

The ACHIA NSW Sector Development Team, including Lynnett, Paula and Simon recently took off on a weeklong, 2,400km adventure from Wonnarua Country to Bundjalung Country and across the top to Yuwaalaraay Country to connect with ACHPs and get a first-hand look at the great work they are leading in their communities.

Starting early on Monday, 15 July and ending close to midnight on Friday, 19 July, the journey began with the fabulous Laurie Perry at Wonnarua Nation Aboriginal Corporation. Laurie is located at the soul of the region and shared with the ACHIA NSW team about how the region is working and developing.



The following day the team had the pleasure of visiting the Hunter Valley Aboriginal Corporation (HVAC), where Kylie Pascoe, CEO, Uncle Gary Wright, and Uncle (Binna) Glen Morris, shared about the remarkable and inspiring journey they have undertaken to reach their current goals. A fabulous platform has been created and it will be great watching the movements of HVAC in the future.

On Wednesday the team had the privilege of attending the Bundjalung Tribal Society's Meet and Greet information session at their Nambunda Farm. The event was opened with Welcome to Country by Uncle Phil and Marcus Ferguson, followed by a dedicated tour of the farm and a walk to the site where the future Aboriginal

Cultures and Eco-Tourism Centre will be constructed. The event also included a lunch featuring produce grown right on the farm, providing a wonderful end to an informative and enriching day.





## Upcoming Events Core and Cluster Services

### **Coercive Control Workshops**

The Centre for Community Welfare Training (CCWT), in partnership with the Department of Communities and Justice (DCJ) NSW, has developed specialised face-to-face training in response to recommendations made by the NSW Joint Select Committee on Coercive Control to support practitioners in identifying and responding to coercive control.

In November 2022, the NSW Parliament passed the Crimes Legislation Amendment (Coercive Control) Act 2022, creating a new offence for coercive control in intimate partner relationships, effective July 2024.

This training will be rolled out between June 2024 and November 2024 in preparation for the new legislation. Almost all courses are full. Checking the CCWT website (checked on 10 July 2024), they have enrolment spots

available at:

## ACHP Grant and Training Opportunities

#### What is a Leading Community Demonstration Site?

The Leading Community Demonstration Site (LCDS) will deliver a new service model for Aboriginal families who may need support to resolve their housing needs, whilst addressing at least one other social issue nominated by the community.

The EOI is targeted to Aboriginal organisations located in NSW and will run for 3 years.

#### How do I know if my organisation is eligible to apply?

Any NSW-based Aboriginal organisation that is driven to deliver positive outcomes for the community may be eligible. The Aboriginal business/organisation must be at least 50% Aboriginal owned and recognised through an appropriate organisation, such as Supply Nation or NSW Indigenous Chamber of Commerce or the like. The organisation must be able to provide evidence that shows the organisation meets these criteria.

#### What funding is available?

Funding for the project is up to \$250,000 for the first year and an additional \$150,000 each year for the following two years.
